

**ROSEBUD SIOUX TRIBE
RESOLUTION NO. 2009-202**

WHEREAS, the Rosebud Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian reorganization Act of 1934 and all pertinent amendments thereof; and

WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with the powers granted to it by its Constitution and Bylaws; and,

WHEREAS, Two Strike is on the list of recognized communities in article II of the Rosebud Sioux Tribe Constitution and Bylaws; and

WHEREAS, Article V of the Constitution gives Two Strike Community the authority to consult and make recommendations to the Tribal Council and Superintendent on all matters of local interest; and

WHEREAS, the Two Strike community met in a duly called meeting with a quorum present on March 26, 2009 to amend Resolution No. 69-80 (amended January 10, 1991) back to the original resolution of 69-80 excluding the grass mountain community boundaries described as: Beginning with the SW corner of Section 24, T37N, R31W; thence north along section line to the SW corner of Section 24, T38N, R31W, an approximate distance of 6 miles; thence East and along section line a distance of 2¾ miles to the Rosebud-Parmelee road; thence in a southeasterly direction and along Rosebud-Parmelee road through the town of Rosebud to the Rosebud-Crookston NE. Junction; thence southeasterly along the Rosebud-Crookston, NE. approximately 4½ miles; thence east along the section line to the Section 9, T37N, R29W, thence south along section lines and Rosebud-Crookston, NE. to the SE corner of Section 21, T37N, R29W, an approximate distance of 3 miles; thence west along section line and north boundary of St. Francis voting district to the SE corner of Section 20, T37N, R30W; an approximate distance of 7 miles; thence north to the NE corner of section 20, T37N, R30W; thence west along section line to the NW corner of section 20, T37N R30W; thence south to the SW corner of section 20, T37N,/R30W; thence west to point of beginning; and

WHEREAS, The Two Strike community recommended the Tribal Council representative to address the Land and Natural committee and to bring back a report regarding the boundaries; and

WHEREAS, The Tribal Council representative addressed the Land & Natural committee and was advised to do a survey on the residents living in the affected land boundaries the survey results were that all residents choose to continue to vote and consider Two Strike community as their residence; and

WHEREAS, The Two Strike community met in a duly called meeting with a quorum present on June 18, 2008 and to present a resolution to Rosebud Sioux Tribal Council to amend/revise and/or rescind the amended Resolution 69-80 amended January 10, 1991; now


THEREFORE BE IT RESOLVED, that the Two Strike community request that the original boundaries be returned to Two Strike community for voting and electoral purposes as this is the desire of the residents; now

THEREFORE BE IT FURTHER RESOLVED, that the Two Strike/Rosebud Community joint resolution concerning Rosebud Dam and Golf Course issue that define the boundaries be brought back to the Tribal Council.
