

RESOLUTION NO. 6971.

WHEREAS, presently there exists a situation which created by Sec. 1 of Article VI of the Constitution and By Laws of the Rosebud Sioux Tribe which required that to qualify to vote in tribal election, the voter must be living in the community at least 90 days prior to the election day, and

WHEREAS, there are no voting districts established for each of the recognized communities listed under Sec. 2 of Article III of the Constitution and By Laws of the Rosebud Sioux Tribe,

NOW THEREFORE, the Tribal Districting Committee of the Tribal Council moves the following Resolution:

BE IT RESOLVED, that the boundaries of MILK'S CAMP community voting districts is hereby established to encompass the following described area:

Beginning in the SE corner of Section 33, T95N, R69W; thence west along Gregory County and Nebraska State Line, approximate distance of 22 miles, to the SW corner of Section 36, T95N, R73W; thence north along county road and section line to the NW corner of Section 13, T97N, R73W; a approximate distance of 16 miles, thence east to Hiway 18, thence north and crossing hiway 18 and along hiway 47 to Seventh Street in Gregory, South Dakota, thence east on Seventh Street to Spencer Street, thence north to Ninth Street, thence west to Main Street, thence north to Eleventh Street, thence east to Felton Street, thence south to Ninth Street, thence east to Logan Street, thence north to the SE corner of the SW $\frac{1}{4}$ of Section 1, T97N, R72W; thence west along section line, a approximate distance of 1/2 mile to hiway 47, thence north along hiway 47 to the NW corner of Section 1, T98N, R72W; a approximate distance of 7 miles, thence east along section line to the west shores of Lake Francis Case, a approximate distance of 17 1/4 miles, thence in a southeasterly direction along the west shores of Lake Francis Case to the NE corner of the NW $\frac{1}{4}$ of Section 35, T96N, R67W; thence south to the Nebraska State Line, a approximate distance of 7 miles, thence west to the point of beginning, a approximate distance of 14 miles.

BE IT FURTHER RESOLVED, that adult members of the Rosebud Sioux Tribe living within the voting district are entitled to vote in the tribal or community election.

CERTIFICATION

We, the undersigned hereby certify that the Rosebud Sioux Tribal Council is composed of 21 voting members of whom 17 members constituting a quorum were present at a duly called and convened session of the Tribal Council held August 26, 1969 at Rosebud, South Dakota, that the foregoing resolution was adopted by the affirmative vote of 12 members, 2 opposed and 3 not voting.
