RESOLUTION NO. 6972.

WHEREAS, presently there exists a situation which created by Sec. 1 of Article VI of the Constitution and By Laws of the Rosebud Sioux Tribe which required that to qualify to vote in tribal election, the voter must be living in the community at least 90 days prior to the election day, and

WHEREAS, there are no voting districts established for each of the recognized communities listed under Sec. 2 of Article III of the Constitution and By Laws of the Rosebud Sioux Tribe,

NOW THEREFORE, the Tribal Districting Committee of the Tribal Council moves the following Resolution:

BE IT RESOLVED, that the boundaries of OKREEK community voting districts is hereby established to encompass the following described area:

Beginning in the SE4 of the SW4 of Section 32, T95N, R77W, in Tripp County: thence west along Tripp County and Nebraska State Line and into Todd County to the SW corner of Lot 4, Section 20, T35N, R26W, an approximate distance of 28% miles, thence north along section line county road and east boundary line of Antelope Community Voting District to the SE corner of Section 32, T38N, R26W, approximate distance of 15 miles, thence west along section line, county road and east boundary of Antelope Community Voting District, a distance of 1 mile, thence north along section line and county road to Hidden Timber road, a distance of 1 mile, thence west along section line, Hidden Timber road, a distance of 2 miles, thence north along section line, Hidden Timber road and crossing Hiway 18 to the Todd and Mellette County line to the Mosher road, thence north into Mellette County along Mosher road to Hiway 40, an approximate distance of 6 miles, thence east along Hiway 40, an approximate distance of 4 miles to the Mellette and Tripp County line, thence south along Mellette and Tripp County line to the NE corner of Section 36, T40N, R25W, a approximate distance of 54 miles, thence east into Tripp County and along section line, a distance of 91/2 miles to the NE corner of Section 14, T99N, R78W, thence south along section line and crossing Hiway 18 to the SE corner of Section 26, T99N, R78W, a approximate distance of 3 miles, thence east along section line and county road to the NE corner of the NW% of Section 32, T99N, R76W, a approximate distance of 8% miles, thence south to the point of beginning, a approximate distance of 25 miles.

BE IT FURTHER RESOLVED, that adult members of the Rosebud Sioux Tribe living within the voting district are entitled to vote in the tribal or community election.

CERTIFICATION

We, the undersigned hereby certify that the Rosebud Sioux Tribal Council is composed of 21 voting members of whom 17 members constituting a quorum were present at a duly called and convened session of the Tribal Council held August 26, 1969 at Rosebud, South Dakota, that the foregoing resolution was adopted by the affirmative vote of 12 members, 2 opposed and 3 not voting.
