

RESOLUTION NO. 6973.

WHEREAS, presently there exists a situation which created by Sec. 1 of Article VI of the Constitution and By Laws of the Rosebud Sioux Tribe which required that to qualify to vote in tribal election, the voter must be living in the community at least 90 days prior to the election day, and

WHEREAS, there are no voting districts established for each of the recognized communities listed under Sec. 2 of Article III of the Constitution and By Laws of the Rosebud Sioux Tribe,

NOW THEREFORE, the Tribal Districting Committee of the Tribal Council moves the following Resolution:


BE IT RESOLVED, that the boundaries of PARMELEE community voting districts is hereby established to encompass the following described area:

The south boundary line begins in the SE corner of section 12, T38N, R31W, and NE corner of ~~Grass Mountain~~ ^{Rosebud} Com. Voting District boundary, thence west along section line and north boundary line of ~~Grass~~ ^{Rosebud} Mountain Com. Voting District, a distance of 4 1/2 miles, thence continuing west 1 mile, north 1 mile and west 2 miles along section line and the NW boundary line of Upper Cutmeat Com. Voting District to the SW corner of section 2, T38N, R32W, and east boundary line of He Dog Com. Voting District, a distance of 3 miles north to the SE corner of section 22, T39N, R32W, thence west along section line, county road and NE boundary line of He Dog Voting District, a distance of 2 miles, thence north 1 mile, thence west along section line, county road and north boundary line of He Dog Com. Voting District, a distance of 4 miles to the SW corner of section 14, T39N, R33W, thence north along section line and county road, to the Todd County line, a distance of 3 miles, the Todd County line borders the north boundary, a approx. distance of 13 1/2 miles, Soldier Creek and Rosebud Com. Voting District borders the east boundary of Parmelee Com. Voting District, a distance of 8 miles.

BE IT FURTHER RESOLVED, that adult members of the Rosebud Sioux Tribe living within the voting district are entitled to vote in the tribal or community election.

CERTIFICATION

We, the undersigned hereby certify that the Rosebud Sioux Tribal Council is composed of 21 voting members of whom 17 members constituting a quorum were present at a duly called and convened session of the Tribal Council held August 26, 1969 at Rosebud, South Dakota; that the foregoing resolution was adopted by the affirmative vote of 12 members, 2 opposed, and 3 not voting.


