

RESOLUTION NO. 6981.

WHEREAS, presently there exists a situation which created by Sec. 1 of Article VI of the Constitution and By Laws of the Rosebud Sioux Tribe which required that to qualify to vote in tribal election, the voter must be living in the community at least 90 days prior to the election day, and

WHEREAS, there are no voting districts established for each of the recognized communities listed under Sec. 2 of Article III of the Constitution and By Laws of the Rosebud Sioux Tribe,

NOW THEREFORE, the Tribal Districting Committee of the Tribal Council moves the following Resolution:


BE IT RESOLVED, that the boundaries of UPPER CUTMEAT community voting district is hereby established to encompass the following described area:

The south boundary line begins in the SE corner of section 19, T37N, R31W, thence west along section line and north boundary of Spring Creek community voting district line to the Todd County line, a approx. distance of 10 1/2 miles, thence north along Todd County line and West boundary, a approx. distance of 5 miles to the NW corner of Lot 1, Sec. 33, T38N, R33W, and beginning of the north boundary, thence east along section line to the Highway 18, thence in a northeasterly direction along Highway 18 to the SW corner of section 21, T38N, R32W, thence north along section line to the NW corner of section 21, T38N, R32W, thence east along section NE corner of section 21, T38N, R32W, thence north along section line to the NE corner of section 10, T38N, R32W, a approx. distance of 10 miles, thence east along section line, a approx. distance of 3 miles, to the NE corner of section 1, T38N, R32W, thence south along section line and crossing Highway 18 to SE corner of section 12, T38N, R32W, a distance of 1 mile, thence east along section line to the NE corner of section 18, T38N, R32W, and the NW corner of Grass Mountain community voting district boundary, a distance of 1 mile, thence south along section line and west boundary of Grass Mountain community voting district, a distance of 8 miles to the point of beginning.


BE IT FURTHER RESOLVED, that adult members of the Rosebud Sioux Tribe living within the voting district are entitled to vote in the tribal or community elections.

CERTIFICATION

We, the undersigned hereby certify that the Rosebud Sioux Tribal Council is composed of 21 voting members of whom 17 members constituting a quorum were present at a duly called and convened session of the Tribal Council held August 26, 1969 at Rosebud, South Dakota, that the foregoing resolution was adopted by the affirmative vote of 12 members, 2 opposed, and 3 not voting.


