WHEREAS, Horse Creek Community has presented a Resolution to the Rosebud Sioux Tribal Council that the boundaries of Horse Creek Community be changed to include the New Swift Bear Housing, and

WHEREAS, a majority of the enrolled voting members of the New Swift Bear Housing together with residents who are also eligible to be enrolled have signed petitions, attached hereto and made part of the Resolution, stating that they want to be included in Horse Creek Community and become a part thereof and that they encourage and support the passing of a Resolution that would extend the boundaries of the Horse Creek Community, and

WHEREAS, the Rosebud Sioux Tribal Council has authority to make such changes in accordance with Article III, Section 3, of the Constitution and By-Laws of the Rosebud Sioux Tribe,

IT IS HEREBY RESOLVED, that the boundaries of Horse Creek Community is hereby established to encompass the following described area:

Beginning in the SE corner of Section 33, T40N, R28W, thence west along Mellette and Todd County line, an approximate distance of 10 miles to the SW corner of Section 36, T40N, R30W, thence north one mile, thence west one mile, thence south one mile to the Mellette and Todd County line, thence west along Mellette and Todd County line, an approximate distance of nine miles to the SW corner of Section 32, T40N, R31W, thence north along section line, an approximate distance of 12 miles, to the NW corner of Section 4, T41N, R31W, thence east along Section line and crossing highway 83, an approximate distance of 19 1/2 miles to the NE corner of Section 3, T41N, R28W, thence south along section line and crossing highway 40 to the point of beginning, an approximate distance of 12 miles.

CERTIFICATION

This is to certify that the above Resolution was duly passed by the Rosebud Sioux Tribal Council in session, March 20, 1979, twenty-five in (25) favor, none opposed, and none not voting. The said Resolution was adopted pursuant to authority vested in the Council. A quorum was present.

AMENDMENT TO RESOLUTION NO. 79-34

BE IT FURTHER RESOLVED, that the boundaries of Swift Bear Community voting districts is hereby established to encompass the following described area:

Beginning in the NW boundary line of Butte Creek Community voting district and the SE corner of Section 8, T42N, R27W, thence west along section line to the SW corner of Section 11, T42N, R28W, a distance of 4 miles, thence south along section line to the NE corner of Section 3, T41N, R28W, a distance of 4 miles, thence west along section line and north boundary of Horse Creek Community Voting District to the NW corner of Section 4, T41N, R31W, a distance of 19½ miles, then north along section line, county road and east boundary line of Corn Creek Community Voting District to the SE corner of Section 28, T45N, R31W, an approximate distance of 21 miles, thence southeasterly direction along the White River and Mellette County line to the NE corner of Section 5, T43N, R27W, thence south along section line, an approximate distance of 8 miles, to the point of beginning.
